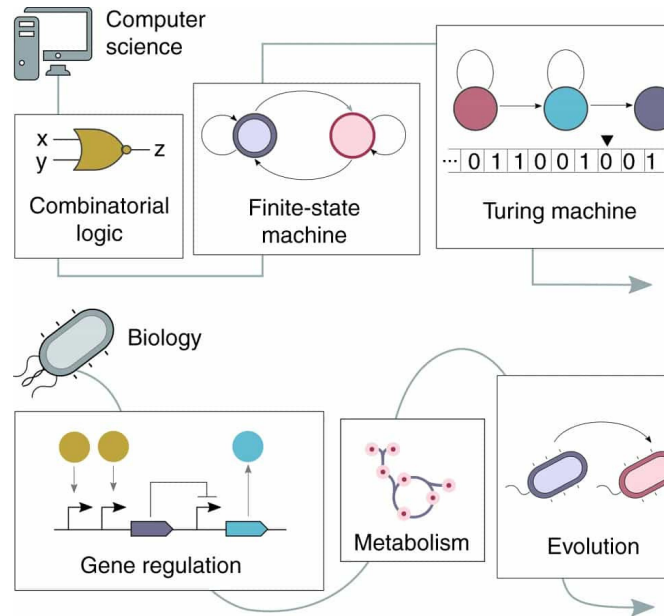


Are You Making An Informed Consent Decison???

The Astrazeneca Oxford vaccine is a viral vector vaccine (I.G.T.) and deals with DNA payloads. The Moderna/Pfizer vaccines deal with mRNA payloads.

So, we have two delivery methods, viral (Astrazeneca-Oxford) and chemical (Moderna/Pfizer). **The result of both injections is that the person is genetically altered to produce the Sars-CoV-2 spike protein. The delivery method is known as transfection.** In the Moderna/Pfizer vaccines Polyethylene glycol (PEG) nano particles (or similar) are used to encapsulate the mRNA and transport it to the cell. In the AstraZeneca Oxford vaccine a chimpanzee adenovirus virus is used to transport DNA to the nucleus of the cell.

Under 42 U.S. Code § 300aa-22 – Standards of responsibility: Paragraph (b), which addresses “Unavoidable adverse side effects; warnings” states, “(1) No vaccine manufacturer shall be liable in a civil action for damages arising from a vaccine-related injury or death associated with the administration of a vaccine after October 1, 1988, if the injury or death resulted from side effects that were unavoidable even though the vaccine was properly prepared and was accompanied by proper directions and warnings. “(2) For purposes of paragraph (1), a vaccine shall be presumed to be accompanied by proper directions and warnings if the vaccine manufacturer shows that it complied in all material respects with all requirements under the Federal Food, Drug, and Cosmetic Act ...” unless the plaintiff is able to show the manufacturer engaged in specific conduct or failed to exercise due care by clear and convincing evidence in its compliance with the Act.

Scientists Warn of Mass Casualty Event of Vaccinated People in the Long-Run, Due to Hyper-Immune Response, Which Will be Blamed on New Strain of COVID to Justify Further Lockdowns and Mandates

According to the US federal Vaccine Adverse Event Reporting System (VAERS), as of February 26th, over 1,000 deaths have been recorded as possibly related to the experimental COVID vaccinations, tens of thousands of reported injuries, and hundreds of permanent disabilities. At least 4,000 of the adverse reactions have rendered people “unable to work,” or perform “daily activities.”
